# To our National Membership

We have received many inquiries from around the country since we filed the Notice of Civil Claim in the BC Supreme Court on Oct 9th 2015 against Commissioner Paulson et al.

We sought to deal with this matter internally and sent messages to all of the commissioned officers, including Commissioner Paulson. To date, we have not received any responses. We sought to have this matter resolved via Minister Blaney's office and the Premier's office, but were provided no redress save to contact the Department of Justice - lawyers.

We believe that the fundamentals of our lawsuit are widespread across the RCMP. As your national association, we are asking that you share this message with every member you know. We believe that many more members will come forward and self-identify that this is happening to them today or that this has happened to them in their careers. For all members who want accountability and redress for the harm which has happened, you need to follow the steps we have outlined below:

1. Members must join MPPAC to become part of this process. You cannot be represented if you are not a member of MPPAC. Become a member at:
