
I attach the Notice of Motion, Affidavit of Dennis Duggan sworn December 7, 2015, and Factum of the Attorney General of Canada seeking an Order of the Court extending the suspension of its declaration of invalidity of s. 2(1)(d) of the *Public Service Labour Relations Act* for an additional 6 months.

In its judgment dated January 16, 2015, the Court suspended its declaration of invalidity for a period of 12 months, expiring on January 17, 2016.
